## **SRA 2011-2012 OPEN VICTORIAN SPRINTCAR TITLE**

### ***AVALON RACEWAY -LARA -11<sup>th</sup> FEBRUARY 2012***

**This event is open only to current SCCA registered Sprintcars and licensed drivers.** The Event will take place under the SCCA racing rules, regulations and specifications as set out in the current rulebook. All drivers must have a current SCCA Competitors licence. A Speedway Australia Licence card may also be required by the venue operators.

## **FORMAT**

**Race distances:** Heats -10 laps, C Main 10 laps, B Main 20 laps, A Main 30 laps  
(The SRA and venue operators reserve the right to alter race format and race distances)

### **Open format (Based on 36 cars)**

#### **Time trials**

3 heats (one heat per car) - Fast time to heat 1, second fastest to heat 2, 3<sup>rd</sup> fastest to heat 3 and so on as per time trial qualifying.

Once the heats are done as time trial qualifying there will be TOP 6 inversion in each heat.

First four in each heat race transfer to the A Main.

Drivers finishing in position 5 thru to 8<sup>th</sup> will go into the B main and grid up as per there time trial qualifying – fastest to the front.

Drivers finishing in position 9 thru to 12 will go into the C main and grid up as per there time qualifying – fastest to the front.

Top six from the C main will go on the back of the B Main in there finishing order.

Top six from the B Main will go to the back of the A Main in there finishing order.

#### **DASH 1**

Drivers that finish 1<sup>st</sup> and 2<sup>nd</sup> in there heat will go into a six lap dash for there A Main starting positions where they finish is there starting order in the A Main. (Dash starting order will be determine by fastest time trial for the heat winners to position 1,2 & 3 and second place getters in the heat will line as per there time trials in position 4,5 & 6.

#### **DASH 2**

As per the first dash for drivers that finished 3<sup>rd</sup> and 4<sup>th</sup> in there heats.

A Main 30 laps  
B Main 20 laps  
C Main 12 laps



Avalon Raceway Lara uses the AMB Transponder System for the purpose of lap scoring and timing. Hire transponders are available at a cost of \$30 incl GST per night. Transponders not purchased through the System Operator at the venue will incur a service fee of \$15 incl GST per night.

**EVENT TIMES: (IMPORTANT PLEASE READ CAREFULLY)**

**In Pits Time 3.30pm** – Sprintcar not in the pits by 3.30pm will not be in the draw and will start rear of there heats race.

**Scrutineering -2.30pm to 4pm any sprintcar not scrutineered by 4pm** will start rear of there heat race.

**Driver Sign In – 4.pm** – Any driver not signed in by 4pm will start rear of there heat race.

**DRIVERS BREIFING** – 5PM

**Engine Starts** – 5.30pm –Engine Starts and Hot laps will be followed by time Trials.

**Nomination Information (Nomination Fee \$50)**

Nominations are to be received **8 days** prior to the scheduled event by Friday the **(3/02/2012)** on the official SRA nomination form (see attachment) **Nomination cost is \$50.00 Inc GST per car**. It is required that if you are making payment by cheque please make out to: **(The Sprintcar Racing Association of Victoria Inc)** in full not SRA or supply credit card details on the nomination form. Faxed and posted nomination forms, accompanied with payment, must be with **Lisa Van Der Elst** within the specified time. **Postal delays are not accepted as an excuse**, please allow five working days for postal service. Phone nominations will be accepted provided full payment details are supplied at the time. **On attendance nomination fees received on time by the (3/02/2012) will be reimbursed**. Late nominations will be accepted, the nomination fee remains at **\$50.00 Inc GST**, but no nomination fee will be refunded to that competitor nominated. If no nomination is received within 24 hours of the race meeting commencing, then the **\$50.00 nomination fee** can be paid on the day of the race meeting, but the competitor will be starting rear of field in ther heat. Any driver whom nominates, but fails to attend the race meeting will forfeit his/her nomination fee, there is no exceptions.

**Scrutineering will commence at 2.30pm till 4.00pm** (sprintcar scrutineered after 4.00pm will have rear of the field starts in there heat race)

All scrutineering will be conducted in a designated area at the venue.

All safety gear, licence and log book must be presented at scrutineering with the sprintcar. Please ensure you have ready your logbook (with SCCA license / infringement book stapled inside the front cover) and SPEEDWAY AUSTRALIA LICENCE Card for inspection if required by the venue operators.
